(22-08-84) Motion Cr. Greer that the minutes from the July 4th meeting be adopted as presented. Crd. The Mayor abstains from voting.

(22-08-85) Motion Cr. Crawford to adopt the agenda with the additions. Crd. The Mayor abstains from voting.

(22-08-86) Motion Cr. Greer to call for tenders on the SEAO website for winter road maintenance for the 2022-2023 season consisting of 81.77 km North of Route 148. Crd. The Mayor abstains from voting.

(22-08-87) Motion Cr. Greer to call for tenders on the SEAO website for the # 1 Firehall major expansion. The Mayor abstains from voting.

(22-08-88) **Permit Application**
