

The regular meeting of the Bristol Council was held in the Townhall on February 5<sup>th</sup>, 2018 at 8:00 p.m. with Mayor Brent Orr, and Crs. Phillip Holmes, Archie Greer, Colette O'Malley, Greg Graham, Brian Drummond and Debbie Kilgour.

- (18-02-11)** Motion Cr. Drummond that the minutes from the January 2<sup>nd</sup> meeting be adopted as presented. Crd. The Mayor abstains from voting.
- (18-02-12)** Motion Cr. O'Malley to adopt the agenda with the additions. Crd. The Mayor abstains from voting.
- (18-02-13)** Motion Cr. Holmes to call for tenders for waste and recycling collection for a two year contract duration. Crd. The Mayor abstains from voting.
- (18-02-14)** Motion Cr. O'Malley to adopt By-Law # 304 pertaining to the General Property Tax Rate, Service Rates and the Annual Interest Rate. Crd. The Mayor abstains from voting.
- (18-02-15)** Motion Cr. Greer to accept the quote submitted by Multi-Routes Inc. for the supply, including transport and spreading of 65 000 litres of calcium at a cost of 0.31 per litre. Crd. The Mayor abstains from voting.

These parcels represent abandoned or inexistent roads or part of roads which the municipality wishes to revert back to the original land owners.
