(18-07-72)	Motion Cr. Holmes to adopt By-Law # 315 pertaining to Open Fires & False Alarms. Crd. The Mayor abstains from voting.
(18-07-73)	Minor Variance
WHEREAS	the property is located on a corner and is considered to have two frontages;
WHEREAS	Zoning By-Law # 312 limits the fence height to 1.2 m within a front yard;
WHEREAS	granting the Minor Variance does not affect the triangle of visibility;
WHEREAS	the increase in height of 2 m for the construction of the fence fits with the building and improves property aesthetics;
WHEREAS	the enjoyment and property rights of neighbouring properties would not be affected;
THEREFORE	Motion Cr. Holmes to approve the Minor Variance application submitted for the property identified as 40 River Road, in order to increase the height limit of the fence. Crd. on division. The Mayor abstains from voting. Cr. Greer and Cr. Graham register their dissidence.

WHEREAS	an application was submitted for authorization of a specific project for the installation of shelters for accommodations and an agrotourism project located at 19 chemin Ninth Line (Lot Pt-12B, Range 8);

WHEREAS	the purpose of the project is to authorize the construction of shelters, 30 m_2 in size, along the Quyon River for an agrotourism project offering accommodations and pick-your-own fruit and vegetable operation;
WHEREAS	the municipality has a by-law concerning specific projects for the construction, modification or occupancy of an immovable;
WHEREAS	this is an eligible project under By-Law #305 on specific projects for the Construction, Modification or Occupation of an Immovable (SCAOPI);
WHEREAS	the project authorization application was studied by the Bristol Planning Advisory Committee during the May 29 th , 2018 meeting, according to the applicable evaluation criteria of By-Law # 305;
WHEREAS	there was a favorable recommendation from the Bristol Planning Advisory Committee in relation of the application for authorization of this project;
WHEREAS	the application for authorization aims to consolidate agricultural activities and the project is unlikely to be a source of nuisance for the surrounding neighbourhood, in accordance with the objectives of the Master Plan in force;
THEREFORE	Motion Cr. Greer that council accepts the draft SCAOPI application for the construction of shelters for the purpose of allowing complementary use to agriculture; accommodations, agrotourism and a pick-your-own operation on the property identified as 19 Ninth Line located in the AG-108 area including:
	 Construction of 2 to 4 basic shelters with an area of 30 m₂; Allowing Class C2 usage for agrotourism; Allowing Class C1 use for accommodations with a maximum of 5 bedrooms for rental purposes.
