

The regular meeting of the Bristol Council was held in the Townhall on June 4th, 2018 at 8:00 p.m. with Mayor Brent Orr, and Crs. Phillip Holmes, Archie Greer, Colette O'Malley, Greg Graham, Brian Drummond and Debbie Kilgour.

- (18-06-58)** Motion Cr. Greer that the minutes from the May 7th meeting be adopted as presented. Crd. The Mayor abstains from voting.
- (18-06-59)** Motion Cr. Drummond to adopt the agenda with the additions. Crd. The Mayor abstains from voting.
- (18-06-60)** Motion Cr. Drummond to authorize the construction of a roof covering a porch on the property identified as Lot 10-4, Range 1. Crd. The Mayor abstains from voting.
- (18-06-61)** C.P.T.A.Q. Application
- WHEREAS this project would promote Agrotourism, a developing activity in the area;
- WHEREAS this project would promote sustainable agriculture;
- WHEREAS this agricultural enterprise would benefit the local economy by providing non-traditional unique produce;
- WHEREAS this proposal would create needed lodging in the area;
- WHEREAS this type of lodging would complement the u-pick agricultural aspect;
- WHEREAS this proposal would provide education on permaculture practices;
- WHEREAS this project would create employment;
- WHEREAS the project is situated in a unique area beside the Quyon River and allows for an adequate buffer zone;
- WHEREAS a particular project application was presented to the municipality in order to address the issue that Agrotourism, throughout the municipality and camping, in this zone, is not authorized within our present zoning by-laws;
- THEREFORE Motion Cr. Greer to support the C.P.T.A.Q. application submitted by Alluvia for a Nature Refuge and Organic Farm on their property identified as Part of Lot 12B, Range 8. Crd. The Mayor abstains from voting.
- Cr. Holmes gives Notice of Motion to adopt By-Law # 315, pertaining to Open Fires & False Alarms. Draft By-Law # 315 was deposited.
- (18-06-62)** Motion Cr. Drummond to contact the owner of the property identified as Lot 4-A-P & 5-P, Range 1, indicating that they are in non conformity of the fence agreement and therefore we will be referring this file to our lawyer for legal advice. Crd. The Mayor abstains from voting.

Drummond to contact our lawyer regarding our liabilities in terms of the events scheduled in a converted commercial building located on Lot 4-A-P & 5-P, Range 1, where permits have not been issued and building codes have not been respected.
