(21-05-46)	Motion Cr. Drummond to accept the tender supplied by Nugent Construction Inc. for Phase 1 of the Beach Renovation Project in the amount of \$246 015.22, taxes extra. Crd. The Mayor abstains from voting.
(21-05-47)	Grant for the Maintenance of Local Roads
WHEREAS	the Ministry of Transport, of Sustainable Mobility and Electrification of Transport paid a compensation of \$720 025 for the maintenance of local roads for the civil year 2020;
WHEREAS	the distributed compensation to the municipality is for current and preventative maintenance of local roads 1 and 2 and includes bridges for which the municipality is responsible that are situated on these roads;

- (21-05-53) Toponymic Standardization and Storage of Address Data of the MRC Pontiac and its Municipalities
- **CONSIDERING** the importance of aligning the various databases identifying addresses across the MRC Pontiac, in order to offer improved service to citizens, including emergency services and property assessment services, planning and the map network;
- WHEREAS the Municipal Council constitutes the competent authority to adopt any new street names or to replace existing ones, including private, forest and unnamed roads;
- **CONSIDERING** the current problem for different government services because there is more than one specific use for same streets within municipalities, especially within the assessment role;
- WHEREAS the Government of Quebec requires that municipalities adopt and make official the specifics of their street names, all of which must be sent to the Commission of Toponymie of Quebec;
- **WHEREAS** the identification of buildings on the territory is essential in the event of an emergency;
- **WHEREAS** the MRC Pontiac is available to support municipalities in this process and validate certain elements, in particular the extensive list of street names;
- **WHEREAS** the MRC is committed to making resources available to compare data and synchronize addresses in a uniform manner;

In addition, in the event of discrepancy with the Commission of Toponymie of Quebec, the Municipality of Bristol authorizes this list to be sent to Toponymie Quebec by the MRC Pontiac.
