WHEREAS	multiple options are available for municipalities to modify, amend or authorize changes within their by-laws;
WHEREAS	the municipality adopted By-Law #305 pertaining to <i>Specific Construction, Alteration or Occupancy Proposals for an Immovable</i> (SCAOI) in 2015, which is intended to allow, under certain conditions, a project to be realized despite the fact that it derogates from the planning by-laws of the municipality.
THEREFORE	Motion Cr Drummond that whenever a proposed project arises within the municipality that is agrotourism in nature, and is not permissible due to the zoning, it would be reviewed on a case by case basis through a SCAOI application. Crd. The Mayor abstains from voting.
