That work has been executed in conformity with these expenditures on Aylmer Road under the management of the municipality and the audit file was created. Crd. The Mayor abstains from voting.

WHEREAS	Julien Gagnon, Public and Civil Security Coordinator of the MRC Pontiac gave the Municipal Council the presentation of the results of this study on September 11 th , 2018;
WHEREAS	the municipal council has studied the various possible scenarios of integration as well as the needs in terms of fire safety of its municipality;

THEREFORE	Motion Cr. Drummond that in response to the study, the municipality would be open to discuss further mutual assistance agreements with our neighbours, Shawville and Clarendon. Crd. The Mayor abstains from voting.

WHEREAS	the 5 th year of the Fire Safety Cover Plan for the MRC Pontiac ended on October 9 th , 2016;
WHEREAS	the revised Fire Safety Cover Plan came into effect on May 1 st , 2017;
WHEREAS	year 1 of the revised Fire Safety Cover Plan ended on April 30 th , 2018;
WHEREAS	article 35 of the Fire Safety Act states that an activity report for the previous year must be prepared, adopted by resolution and sent to the minister each year;
WHEREAS	during the transition period that began on October 10 th , 2016 and ended on the date of the coming into force of the revised cover plan on May 1 st , 2017, the MRC and its municipalities continued steps to maintain the exemption of liability provided for in Section 47 of the Fire Safety Act.
